Protecting Your Business with Non-Compete Agreements

n many occasions, an irate client has called my office and advised me that one of its former employees has gone into business in competition with my client and is attempting to solicit its customers. When asked whether any action can be taken, my first inquiry is whether the employee signed a non-compete agreement. If the response is in the negative, I advise the client that there are few actions that can be taken and the ones that are available would be costly and not likely to succeed. I then advise the client that if it wants to avoid such a problem in the future, it should have current and new employees sign a noncompete agreement.

Florida non-compete agreements, signed after 1996, are governed by Florida Statutes § 542.335 which provides specific requirements for these agreements. Florida Statutes § 542.335, identifies five separate "legitimate business interests" that an employer may seek to protect with a non-compete agreement.

The statute then sets forth the length of a non-compete that, in most circumstances, will be enforceable in court. For instance, with most employees, a duration of two years or less is acceptable.

Although the statute does not set forth the acceptable geographic scope of a noncompete, the general rule is that it must be reasonable to protect the employers' business interests. For instance, an employer that only does business in Broward County, Florida, might not be able to enforce a noncompete prohibiting an employee from competing in Dade, Broward and Palm Beach Counties.

As with any legal document, in drafting or enforcing a non-compete you should seek the legal advice of counsel.


